**Scope of Work**

1. Receive proposed development submittals and review them for conformity with current City of Sunset Valley’s Code of Ordinances and other applicable regulations.
2. Provide review comments to the City of Sunset Valley for distribution to developers and developer’s architect / engineer.
3. Assist the City of Sunset Valley and developers in resolving issues and mitigating review comments.

**Client’s Responsibilities**

Client shall provide any pertinent information on development activity in the proximity of a proposed development for which a submittal has been made.

Client shall provide any pertinent information on key understandings, informal agreements, firm/contractual commitments and/or City Council actions related to a proposed development for which a submittal has been made.



Client shall provide any pertinent information on a proposed development's impact to City of Sunset Valley's infrastructure, including any plans on mitigation.

### **Schedule**

The Engineer shall provide initial review comments on development submittals within 10 working days of receipt from the City of Sunset Valley. The Client shall specifically notify the Engineer if a shorter response time is required.

Review of re-submittals/interim documents and requests for other scopes of services listed herein will be completed in a reasonable period unless specific response times are requested by the City of Sunset Valley.

### **Compensation**


