Council Member Rosengarten made a motion to approve on consent Agenda Items #5, 6 and 8, seconded by Council Member Reetz. All voted in favor and the motion carried.

- 7. Consider and act on a recommendation from the Budget and Finance Committee for employee compensation. (Mayor Bruner/Administration)

Council Member Rosengarten made a motion to approve up to a 3% merit increase based on metrics met for City Staff, excluding the positions of City Administrator, Chief of Police, Public Works Director, Assistant to the City Administrator/City Secretary, and the Accounting Assistant/Utility Billing Clerk. The motion was seconded by Council Member Johnson.

Council Member Rosengarten withdrew her motion, with agreement from the second.

Council Member Reetz made a motion to approve a 3% increase to all employees, with the exception of the City Administrator, Public Works Director, and the Chief of Police, with the exception of Public Works Maintenance Techs who will receive a 10% increase, and with the exception of Police Department employees who are a part of the STEP Program, who will then be eligible for the STEP increases they did not receive in 2020. Mayor Pro tem Medicus seconded the motion.

the City Administrator, and proposals of a merit increase for the City Administrator by the City Council. The motion was seconded by Council Member Rosengarten.

The motion was seconded by Council Member Carmona. All voted in favor and the motion carried.

Lamar. The motion was seconded by Council Member Rosengarten.
