SUBJECT: CONCERNS REGARDING ILLEGAL CAMPSITE IN THE 2600 BLOCK OF WESTGATE BLVD

DESCRIPTION: Discussion regarding the illegal campsite in the 2600 blk of Westgate Blvd and incidents of theft/criminal trespassing in neighborhood off Jones Rd

BACKGROUND: In August 2021 the City of Austin reinstated a ban on public camping. Weeks later, the State of Texas enacted a statewide ban on public camping. Enforcement efforts in open public spaces such as the 290 underpasses, resulted in an increase of illegal camping in nearby wooded areas. Two areas of concern to Sunset Valley residents are the greenbelt near the Brodie bridge and the large campsite in the 2600 block of Westgate along the eastern city limits.

Brodie Bridge Campsite

Beginning in September 2021, the police department began receiving calls about illegal campsites along the nature trail in approximately the 5900 block of Brodie Ln. Concerns were related to trash, debris, and disorderly conduct during the overnight hours. In October and November 2021, the Department cleaned up three sites in the area. However, callers still report camping activity and disorderly in the area just outside of the ETJ of Sunset Valley.

Westgate Campsite

In early September 2021, a large illegal campsite developed on private property in approximately the 2600 block of Westgate. During that same period there were reports of criminal trespass, stolen bicycles and mail thefts on Reese, Sunset Trail, and Pillow. On several occasions' officers contacted suspicious persons in the area that were linked to the Westgate campsite. Sporadically, since September there have been reports of thefts and trespassing from Sunset Valley residents on the Next-door app. Officers from Sunset Valley, Austin PD, and Austin Fire/EMS are aware of the campsite and its residents.

The purpose of this discussion is to solicit ideas from residents about collaborating with the City of Austin to remove illegal campsites that are impacting safety and security in Sunset Valley.
