



## **ORDINANCE NO 110920-C**

AN ORDINANCE OF THE CITY OF SUNSET VALLEY, TEXAS AMENDING WATER AND WASTEWATER RATE SCHEDULES, DETERMINING THAT NO REVISION IS REQUIRED FOR DRAINAGE UTILITY RATES AS PROVIDED IN CHAPTER 53 OF THE CODE OF ORDINANCES, PROVIDING FOR AND EFFECTIVE DATE AND SEVERABILITY.

WHEREAS, the City Council of the City of Sunset Valley, Texas, deems it necessary to adopt water and wastewater rates in accordance with a cost of service model that has been used in the preparation of the Fiscal Year 2011-12 Annual Budget; and

WHEREAS, the cost of service study provides for the equitable distribution of costs between fixed and variable costs, and between classes of customers; and

WHEREAS, the City of Austin has notified the City of Sunset Valley that Wholesale Water and Wastewater rates will be increasing by the terms and conditions of contracts between the two cities; and

WHEREAS, the City Council of the City of Sunset Valley, Texas, deems it that no revision is necessary to the Drainage Utility Rates as outlined in Section 53.19(H) of the Code of Ordinances;

# NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SUNSET VALLEY, TEXAS THAT:



# DRAINAGE UTILITY CHARGES

No revision is to be made to the Drainage Utility Charges as contained in Chapter 53 of the Sunset Valley Code of Ordinances.

<u>Section 2.</u> Effective Date. This Ordinance shall become effective with the first utility billing cycle that begins after October 1, 2011.

**Section 3**. **Severability.** If any provision of this Ordinance is found by a court of competent jurisdiction to be void or unenforceable, such void or unenforceable provision shall be severed as though it never formed a part of this Ordinance, and all other provisions hereof shall remain in full force and effect.
