AGREEMENT FOR PROMOTIONAL SERVICES

This Agreement for Promotional Services ("Agreement") is entered into by the City of Sunset Valley ("City") and Mindful Marketing ("Contractor") effective the 1st day of October, 2014.

WHEREAS, the City annually sponsors and promotes an arts festival in the City to attract tourists to the City, and expends Hotel Occupancy Tax in the promotion thereof;

WHEREAS, Contractor is in the business of advertising, promotion and public relations, with experience in promoting similar events; and

WHEREAS, the City and Contractor desire to arrange for Contractor to promote the City's arts festival scheduled for April 25, 2015 (the "Festival") on the term provided herein,

NOW, THEREFORE, the City and Contractor agree as follows:

- (1) Contractor shall perform the following services:
 - a. Coordinate with City's Arts Commission, in arranging a schedule of events and all logistical arrangements for the conduct of the Festival, including but not limited to coordinating with agents of the City the services and facilities described for the Festival.
 - b. Recommend all advertising content and outlets, and arrange and implement a program of such advertising with the approval of the Art Commission;
 - c. Recommend brochures, signage, and other promotional materials, and arrange the preparation and publication and installation of same with the approval of Arts Commission;
 - d. Coordinate with all artists presenting at the Festival regarding scheduling and logistical arrangements in accordance with schedules and arrangements approved by Arts Commission;
 - e. Develop and recommend a form or survey for evaluation of the Festival and provide an opportunity for participating artists to evaluate the Festival;
 - f. Prepare and recommend a budget for the Festival to be approved by arts Commission and assist the City in implementing such approved budget; and
 - g. Solicit donations, and volunteers in the Festival by local merchants and residents, and coordinate the duties of volunteers and the work of volunteers during the conduct of the Festival.
- (2) For the services to be provided, the City shall pay Contractor in the amount of \$13,000.00, payable by equal payments from October 1, 2014 April 30, 2015.
- (3) Contractor shall maintain complete and accurate records of services performed pursuant to this Agreement, which shall be made available for inspection upon request by the City.
- (4) All services performed by Contractor and fees to be paid by the City shall be in compliance with Subchapter B of Texas Tax Code Chapter 351. The City and Contractor shall cooperate as reasonably necessary to ensure compliance with all applicable law.
