

SUBJECT: Crime Control Prevention District Tax

DESCRIPTION: Discussion on Crime Control Prevention District Tax

In November 2021, Sunset Valley residents will vote on whether or not to continue the Crime Control and Prevention District Tax. Crime Control and Prevention Districts are authorized under Texas Local Government Code Chapter 363 as a means to supplement crime suppression efforts. The Sunset Valley Crime Control and Prevention District was established in November 2016 following a vote by Sunset Valley residents. The CCPD was initially created to contribute to the funding of the new police facility by implementing a 1/8th of a cent tax on sales tax revenue.

Although the general fund budget typically funds the police department, the CCPD budget currently offsets the police department budget which allows general fund dollars to be stretched even further. The current CCPD budget is over \$400,000 and the following programs are currently funded by the CCPD:

1. Salaries and benefits for investigator and 2 officers
2. Cell phones
3. Police radios
4. National Night Out
5. Travis County S.O. dispatch fees
6. Software maintenance expenses

The current CCPD expires in 2021 and may be continued by referendum for a period of 5, 10, 15, or 20 years.
