1. Call to Order. **Meeting called to order at 6:01 PM**
2. Public Comments. **Myles Fox requested that the PSC look into the issue of video monitoring for public streets. Mark Wells discussed graffiti on public property on Jones Road and suspected car burglaries on Sunset Trail.**
3. Approval of minutes from April 26, 2021 **Motion to approve Ruth Dawson. 2nd Michael Moore**
4. City Council Liaison Report **CM Rob Johnson updated the PSC on the Crime Control Prevention District tax and discussed art on public utility boxes as beautification projects.**
5. Discussion on community safety and environmental concerns (Objective 2.2 PSC Goals and Objectives) **Chief Carter discussed incidents of graffiti targeting the utility box and sidewalks near Jones Road and Westgate. The police department placed a game camera in the area but no suspect(s) were identified.**
6. Discussion on Crime Control Tax (Objective 1.2 PSC Goals and Objectives) **Chief Carter informed the PSC that in November residents would be voting on a referendum for a 5-year extension of the 1/8th of a cent tax on sales revenue to fund crime control efforts in the city.**
7. Presentation on area crime statistics (Objective 2.2 PSC Goals and Objectives) **Chief Carter presented a comparison of Sunset Valley year-to-date offenses versus City of Austin David sector (area surrounding the city of Sunset Valley).**
8. Consideration of new business **Topics for new business included: request for speed bumps on Sunflower Trail, decreasing speed limit in the Villas, re-painting faded crosswalks in the city, and more frequent removal of curbside brush piles.**

The FY 19-20 budget included \$30,000 for the police department to purchase mobile, pole-mounted, surveillance cameras to assist with crime prevention in the shopping centers, trailheads, residential areas, and public events. This project was scheduled to be completed by June 2020 but various delays have hindered completion of the project.

Kraig Gardner from Flock Safety is meeting with the PSC to discuss his company's surveillance camera system as a possible solution.
